Dear Church President, Administrator, Minister, or Membership Chair,

I am writing from the Office of Data Services to inform your congregation about the UUA's Certification of Membership 2010. You can now log in to the online system to certify membership and statistical information in time for the deadline: **Monday, February 1, 2010 at 5 p.m. Pacific time.**

The certified membership number is the basis for determining the number of voting delegates for your congregation at General Assembly 2010, and for calculating your congregation's Annual Program Fund Fair Share (FY 2011) contribution to the UUA. You must certify your congregation's membership number and statistical information each year by 5:00 p.m. Pacific time, February 1. These numbers cannot be changed using our online system between February and July without permission from the Secretary of the UUA. The online form for Certification of Membership includes a *Congregational Poll* ballot to determine whether the Draft Statement of Conscience (SOC) on Peacemaking will appear on the Final Agenda for General Assembly 2010. It also includes a poll to choose up to five Congregational Study/Action for the 2010-2014 Social Witness Cycle. You can log in to your congregation's Data Services account to submit this information in time for the deadline. To log in, visit [www.uua.org/leaders/dataservices](http://www.uua.org/leaders/dataservices) and select the "Data Services Login for Congregations." Then enter your congregation ID number and your password. Your congregation's four-digit ID number appears in any copy of the UUA Directory, or you can find it by searching for your congregation at [www.uua.org/cong](http://www.uua.org/cong). If you don't know your congregation's password, click the "Forgot your password?" link and you will receive an email with instructions to reset the password. After logging in, the updater is asked to enter his or her name.

By certifying membership on this web site, you will guarantee that your membership number is recorded by the February 1 deadline. You will also be able to make updates to your congregation's mailing and meeting addresses, phone, email, and other contact information.

We suggest that you do the following as soon as possible:

1. Log in to the Data Services web site to make sure you know your congregation's ID number and password.
2. Print out the Certification Worksheet, which can be used as a hard copy form to help you collect the information before you submit the totals in the online system.
