PROGRAM DESCRIPTIONS

Pre-GA Supervision is available for children (age 6 months - 10 years) on the Wednesday (6/22) prior to GA. The number and ages of the participants determine the specific program and activities. 8:00 a.m. - 6:00 p.m. The minimum fee per child is \$35/day.

Child Care Daytime Child Care for infants (6 months) and children through age 5 will be offered during GA. Children will be cared for by professional child care workers in a setting that provides both activities and quiet time. The registration fee includes lunch and snacks. Parents must furnish baby supplies baby food, or other special food. Child Care is available from 7:30 a.m. to 6:00 p.m. on Thursday (6/23), Friday (6/24) and Saturday (6/25), and 8:30 a.m. to 6:00 p.m. Sunday (6/26). The Child Care program is subsidized by the UUA at more than \$300 per child. Please pay as you are able; the minimum fee per child is \$35/day.

Day Camp Children ages 6 through 10 may enroll in Day Camp, a daytime program that offers activities and participation in appropriate GA programs. The registration fee includes lunch and snacks. Day Camp is available from 7:30 a.m. to 6:00 p.m. on Thursday (6/23), Friday (6/24) and Saturday (6/25), and 8:30 a.m. to 6:00 p.m. Sunday (6/26). The Day Camp program is subsidized by the UUA at more than \$300 per child. Please pay as you are able; the minimum fee per child is \$35/day.

Young Fun Young Fun is a full-time overnight program for youth ages 8 through 14. Young Fun will be held at an offsite location. Activities will include field trips, workshops, games, athletics, arts and crafts, and attendance at selected GA events. Kathleen Murphy, km123@hotmail.com, is the Young Fun Director; she supervises a staff of UU adults who will be with youth throughout the week. Young Fun begins on Wednesday (6/22) and concludes on Monday (6/27) at 6:00 p.m. The registration fee is \$500 for the first child from each family and \$450 for each additional child; the fee includes all meals, lodging, and activities.
