



Youth registration is required for all GA attendees aged 14-17

Youth aged 18-20 are not required to register as Youth, but must do so in order to obtain the youth registration rate.

Each youth under 18 (born after 6/24/91) must obtain the permission of their parent or legal guardian to register online for GA.

If you will be under 18 at the start of GA, your parent or legal guardian must electronically sign your online registration, acknowledging their knowledge of and permission for your General Assembly online registration.

Youth Caucus at General Assembly

Youth Caucus is the blanket term for all youth programming that happens at General Assembly. Youth Caucus is a group of UU youth, ages 14-20, which participates in regular General Assembly programming and holds programming specifically for youth, including daily meetings to discuss and take part in GA business. All General Assembly attendees aged 14 to 17 must register as Youth, though they are not required to attend any youth-specific programming after the youth-sponsor orientation. Youth aged 18-20 are encouraged but not required to register as Youth.

Each youth under 18 (born after 6/24/91) who attends GA must have a GA-registered adult sponsor who is responsible for the youth's supervision and well-being. GA attendees aged 25 and over may sponsor up to three youth, with whom they are responsible for checking-in frequently and providing support. We require youth sponsors to stay in the same housing as the youth they are sponsoring. Youth Caucus staff is responsible for youth programming and support at GA, but not supervision.

However, Youth Caucus staff does take action when violations of the Code of Ethics occur, which may result in the youth being asked to leave General Assembly at his/her/hir own expense. In such an event, the sponsor is responsible for getting the youth home safely.

The Energy Committee is called together to address rule infractions and behavior that is destructive to the community. Its membership consists of one chaplain, the HUUPER (a youth who serves as the Dean of Youth Caucus), a representative of the UUA Youth Ministry Office and youth from Youth Caucus. The Energy Committee only meets when members of the GA community bring forth serious concerns. It is the job of the Energy Committee to, by the above standards, deem any such behavior inappropriate and to determine consequences. Parents, guardians, sponsors, and youth are encouraged to discuss this policy with each other.

All youth and their sponsors (both parental and non-parental sponsors) are required to sign the Code of Ethics included on these forms. This code serves as a covenant that we have with each other in order to keep the community, and all members of the community, safe and healthy. In the interest of creating a safe, intergenerational community at GA, sponsors are expected to abide by the same Code of Ethics as the youth. If you are sponsoring a youth, you may not drink alcohol at GA.

General Assembly Youth Caucus is a very different event from youth conferences. There will be hundreds of youth attending General Assembly and it is not possible for the General Assembly Youth Caucus staff to provide enough adults to be responsible for that many youth. Therefore, it is imperative that parents, youth and their sponsors know and understand the expectations related to youth sponsorship at General Assembly.

To complete registration, each youth 14-17 must provide:

Full payment of registration

Signed Code of Ethics and Policy on Sexuality and Community

Adult Sponsor Responsibilities Acknowledgement (Note: must be completed even if youth's sponsor is their parent)

Parent Permission for Sponsorship (If sponsor is not the youth's parent or legal guardian)

Each youth 18-20 must provide:

Full payment of registration

Signed Code of Ethics and Policy on Sexuality and Community

Incomplete registrations will not be accepted or processed.

CODE OF ETHICS AND POLICY ON SEXUALITY AND COMMUNITY FOR YOUTH AND SPONSORS

I am attending the 2009 General Assembly (GA) in Salt Lake City, Utah.
I understand my behavior will affect the Youth Caucus community.

While attending GA, I will:

- Act in ways that encourage the well being, safety, and best interests of the youth and all those attending GA.
- Follow the Policy on Sexuality and Community.
- Respect my roommates, the larger GA community, and those in the hotel and the city who are not part of the GA community.
- If in a leadership position (delegate, staff, youth council member, etc.), I have read, understood, and will abide by the Code of Ethics for Youth in Leadership Positions.
- Abide by all state and local laws.

I understand that:

- The UUA Youth Ministry Office does not provide adult supervision for those under 18 during the week of GA and therefore I will work out a system of communication with my sponsor during the week of GA that is mutually satisfying.
- GA is not a youth conference, which means that: Youth are responsible for managing their own time; Youth are not required to stay on site; Sponsors act as legal guardians for youth under 18.
- If any rule violation occurs a committee of youth, my sponsor, my parents and myself may be called together to decide the consequences for my actions.
- Youth who are registered for GA are prohibited from drinking alcohol while at GA. We expect that adult sponsors of youth will also model this behavior for their sponsored youth by refraining from drinking alcohol at GA.

Policy on Sexuality and Community

Our goal is to uphold healthy communities, healthy relationships and to discourage sexual activity and harassment in the conference community. Healthy relationships are based on responsibility, respect, love, and commitment. Healthy sexual relationships are respectful, consensual, pleasurable, safe, caring, developmentally appropriate, and based on mutual expectations. Sexuality is an important part of young people's lives. In the conference community, youth are encouraged to express themselves in healthy ways and respect each other's boundaries. However, behavior that breaks down the community, including sexual activity and sexual harassment, is inappropriate and therefore not permitted in a conference setting.

Code of Ethics for Youth in Leadership Positions

Youth in leadership positions are uniquely visible and influential in any conference community. They should recognize that power imbalances exist in their interactions with other conferees. Inappropriate sexual behavior is never acceptable; additionally, youth leaders should remain aware of the impact of their actions and behave accordingly. Youth who abuse their roles as leaders, consciously or not, can damage individuals and the community. Youth leaders are expected to use their influence in a positive manner.
