PROCEDURE FOR NOMINATION BY PETITION

DEADLINE FOR NOMINATION

This nomination form may not be filed before October 1, and must be filed on or before 5 p.m. February 1, to be valid. (Whenever Feb. 1 falls on a weekend, the deadline is extended to the next business day.)

BYLAW PROVISIONS FOR NOMINATION BY PETITION

Section 9.5. Nomination by Petition.

- (b) ***For Other Elective Positions at Large.** A nomination for any other elective position at large or to fill a vacancy in an unexpired term occurring prior to December 1 of the year before the election may be by petition signed by not less than fifty members of certified member congregations, with no more than ten signatures of members of any one congregation counted toward the required fifty. A separate petition, in the form prescribed by the Secretary, shall be filed for each nomination not later than February 1 of the year of the election and not earlier than the preceding October 1. A nomination for trustee at large from Canada shall be so designated.*

INSTRUCTIONS

- 1) Only one petition may be submitted for each candidate. A petition consists of the Petition Cover Page, Petition Signature Pages from at least five congregations and the Certification of Congregation Membership.
- 2) All parts of the petition must be submitted together. If signature pages are received separately, they will not be collated with the petition.
- 3) Petitions received after February 1, will be accepted if and only if they are postmarked on or before January 25. (See UUA Bylaws, Rule G-13.4.1 and G-13.4.2 for specifics.) The Secretary cannot grant any extensions.
- 4) FOR POSITIONS AT-LARGE (EXCEPT MODERATOR OR PRESIDENT): A petition must be signed by at least fifty voting members of Certified member congregations, with no more than ten signatures of members of any one congregation counting toward the required fifty.
