






# "Mainline" Protestantism

- Large regional and national bureaucracies
- · Much time spent on internal disputes
- Talk across denominations
- · Congratulate themselves on their virtues
- Treat all congregations equally, with no special attention to the larger growing ones
- · No sense of urgency for spiritual transformation
- · Ask very little in terms of spiritual or financial commitment
- Evangelism is largely absent



### **Growing Churches**

- Clear and simple religious message
- · Not affiliated, or loosely affiliated, with a denomination
- Very high expectations of their members
- · Focus on spiritual transformation of members, not internal disputes over governance or policy
- Never satisfied with status quo
- Leadership is ministry to others



### **Growing Churches**

- Few or no committees!
- · Externally focused
- Program focused: meeting the needs of their members
- High involvement with and expectations for their youth
- Knowing they have found a good thing, they want to share it with the world!

# How Can We Grow?

- Focus on growth as a strategic priority, measuring each move with respect to whether it helps us to grow
- Stop emulating, in our own behavior, the mainline Protestant denominations
- Focus more energy on the larger, growing churches in our movement
- The larger churches are 4% of our congregations but 21% of our adult members!





# How Can Your Congregation Grow?

- · Externally rather than internally focused
- · High expectations of members
- · Meet the needs of your members
- · Mission not governance
- · Be truly transformational and personal
- · Be worthy of our youth and young adults!
