Opening Words – Wendy	Wendy offered an opening reading that José had previously posted to the ministers' chat, from Carolina Hospital.

Board Liaison – José	José had nothing to report regarding the BoT. Wendy asked when there might be a Board response to where the JTWTC fits organizationally and in terms of policy governance.	The JTWTC will receive a response from the BoT after its October meeting.
President's Rep – Taquiena	Around transition: Harlan Limpert has been in conversation with Devorah Greenstein regarding accessibility resources to Congregational Life. The CL staff is meeting before GA and one of their agenda items is accessibility services and programs.	The JTWTC will have a future conversation around the structural changes in the UUA and how they might affect the committee.
	The staff group that will be known as Multicultural Growth & Witness met for the first time this last week. Some of the conversation was around broadening congregations' understanding of multicultural ministry.	
	Taquiena gave some clarification around the role of Congregational Life versus Multicultural Growth & Ministry, as	

well as that staff group's definition of growth.

Wendy asked how the accessibilities transitions have affected Equual Access. **Taquiena** deferred to **Arthur**, who said that he and Carol Agate met with Peter Morales in March. At that time, they had the draft of the "related organizations" letter, which stated that Equual Access would be "assigned" to MG&W. Subsequent to that meeting, they had a meeting with Harlan Limpert when **Taquiena** advised them that they were being switched from MG&W to CL. Harlan's basic message was that nothing could be done until September when Terasa Cooley comes on. He feels very strongly that CL is the right place for Equual Access to be, but Equual Access disagrees; they feel very strongly that the social justice/equality part of Equual Access should be stressed, not the physical accessibility part. They feel that people might be confused about what's important. **Arthur** invited **Taquiena** to comment, as she was present at the meeting where the decision was made. **Taquiena** says that there were several threads of conversation around accessibility; one had to do with what the UUA was uniquely qualified to do, and where services & programs should live based on what the association's work is. There were also conversations around helping congregations to do effective ministry—linking congregations with resources and empowering them to do the transformative work themselves. If congregations aren't doing the work to meet the ministerial need of various communities. UUism will become irrelevant and ineffective. When **Taquiena** and Harlan spoke last week, Harlan said that a number of programs will be in the same situation—of figuring out what's best and most effective over the next several months considering that some people are leaving and others are coming
