Community Building

Under the facilitation of consultant Sharon Blevins, the new committee began our work together as a team with community building activities that included developing a covenant statement with one another, some identity work through the use of Edward DiBono's "Six Thinking Hats" model, and sharing with one another our strengths, weaknesses, learning styles, conflict-management styles, hot button issues, and what we need from one another.

Throughout the weekend, the committee continued to build trust through worship, story-telling, learning to use the Consensus Building model, sharing our Myer-Briggs indices, doing identity work, and practicing compassionate communication skills.

Committee Work

The following issues were discussed:

- Desired leadership skills and qualities for candidates seeking UUA Committee membership
- Orientation of new Nominating Committee Members. A "buddy" system was established to pair up new members with more experienced members for the purpose of learning/teaching and easing the transition -- Dick with Joan, James with Megan, Bob with Mandy, Hope with KokHeong, and everybody with Helen
- Transition. We discuss the need to create a balance between the continuation of the committee work versus the confidentiality of past committee work. The committee decided that all application documents would be shredded after each election, with only one copy kept by Nancy Lawrence at the UUA.

- Tracking term expiration for current members of UUA Committees and their eligibilities for continuing services. The committee decided that the chairs of the committee would be contacted by letters to remind them when certain members' terms are up.
- Presentation of slate. The committee unanimously voted to present an uncontested slate for each election. The slate would be shared with the UUA President and Moderator prior to their being presented to the UUA Board.
