# GACS update - LaTonya

Planning for Sept, GAMAP & Grid meeting; survey has been sent; Providence visit tomorrow; Staff retreat went well, visioning work and new initiatives; continuing to work on budget; no results at the end of the closing of the books. Spokane was possibly a 6 figure loss.

# 400th Anniversary - Rev. Susan Fredrick-Gray

400th Anniversary of the Mayflower and telling the story from a different vantage. SFG has been holding this work for the past year.

In Nov. 2018, SFG gathered a small group of Indigenous UUs: Clyde, Danielle D. Karen Gramer (climate justice) Karen Von Faucet

Conversation around advanced materials, reading and potential curriculum with Faith Development prior to GA2020. The 2012 Justice GA voted to repudiate the *Doctrine of Discovery* which is still used today as legal precedent to undermine treaties and sovereignty rights of indigenous tribes.

Meeting with Leaders in Providence & 3 Indigenous nations is scheduled for the fall of 2019 to explore ways people can be brought together.
