Credentials Awarded

During this program year, we awarded credentials: 5 Associate Level, 8 Credentialed Level, and 1
Master Level. Of those receiving Associate Level, one had sought Master Level, and another
Credentialed Level.

Highlights

- We interviewed 11 candidates at our annual meeting this spring and expect even more
 interviews to be scheduled for 2017. As the number of interviews has grown, the RECC budget
 has not kept pace. The committee has responded to this challenge by developing a more
 streamlined process for candidate materials review and interview questions development.
- The updated 2014 Plan has been quite well-received. The RECC is finding the candidates who go through the program on the updated plan to be well-prepared and to have found the REC process one of meaningful professional growth.
- May 2016, the RECC sent to the UUA Board for approval, updated committee rules and policies, written to bring them up-to-date and in alignment with our current plan and protocol.
- The RECC has found Jan Gartner, Professional Development Specialist, an extremely effective
 partner in doing the work credentialing professional religious educator. Jan's blend of manager
 and visionary are rare and served well to help move this fairly new program to the next phase of

- its development. We are deeply appreciative and will feel her absence as she moves to her new role at the UUA July 1.
