# **Meeting Minutes**

# **Resolution on Trump Resignation**

Board members discussed a possible resolution calling on President Trump to resign, prompted by a call from the Movement for Black Lives. Members discussed how to be theological and strategic in such a resolution, and requested feedback from legal counsel before moving forward.

## **Association for UU Music Ministries Update**



Members noted that the GA Planning Committee had asked the Board of Trustees to take over negotiations with the AUUMM following their withdrawal from General Assembly planning. Greg Boyd as GAPC liaison and Charles Du Mond as incoming Co-Mod said they would be following up with AUUMM this week, after which the Board would put out a public statement on this process, summarizing actions to date by the GAPC and the Board and the process for moving forward.

#### JTWTC/COIC Resolution

Board members noted they were drafting a responsive resolution to the Commission on Institutional Change's GA report, which would commit to implementing recommendations for a new intersectional accountability group and sunset the Journey Towards Wholeness Transformation Committee. Members were asked to review the resolution and offer feedback in the next few days.

#### **EXECUTIVE SESSION**

The Board moved into Executive Session at 9:10 pm to discuss appointments to the Article II Study Commission.

It was later reported that Paula Cole Jones, Cheryl M. Walker, Rob Spirko and Becky Brooks were appointed to the Study Commission. The Board noted its intent to appoint youth members as well in the coming months.
