**Appendix 1 – General Assembly 2020 Debrief**

- Our ability to work interpersonally sometimes saves us from the most difficult messes
- Ranked among the best GAs, pulled it all off as a team
- Things that might have flared up were contained, with systems (e.g. Chaplains and Right Relationship Team) and organizing
- Still exhausted, even though it was a different physical experience
- Makes us think about the possibilities for future virtual GAs
- Need to work on the systemic pressures that made musicians and youth and young adult leaders pull away
- Excited to continue with COIC work
- We've learned we can do things in a different way that is so much more accessible
- This was a referendum on the work of the UUA to dismantle white supremacy, and it was a resounding affirmation that gave many of us hope, especially given how many people participated
- The outside world is taking notice that the UUA has endorsed #defundthepolice
- Great to have Board Slack channel operating, want to continue that
- Helping us rethink what inclusion means
- General Sessions were great with the chat rooms to help people participate
- UU the Vote met their 100,000-voter contact goal
- The material on demand is really important, allows people who are working all thru GA to get access to the content
- Virtual business sessions helped us get to a greater unity of purpose
- How can we help people push their imaginations even further for what GA could be, and invite people to share their ideas across our congregations?
- Strong fundraising for the collections, probably \$185,000
- Great youth connections, the chat and Slack channels really worked
- So many first-time attendees, and people came away with real excitement about the COIC and the UUA
- GACS staff, GAPC, UUA staff did so much work
- The theme really held together and led the attendee experience



## **Appendix 2 – Resolution on the Use of FY20 Operating Funds**

The COVID-19 pandemic has had major financial impacts for the UUA. As these impacts are fully felt in the next two fiscal years, the UUA expects declines in income from congregational giving, endowment returns, and other sources. However, in the immediate term there is a onetime opportunity to invest in the UUA’s long-term priorities of implementing recommendations from the Commission on Institutional Change and rethinking the planning of General Assembly. With the reduction of travel and events this spring due to COVID-19, especially the shift to a virtual GA 2020, the UUA expects expenses to come in under operating budget this fiscal year. The FY20 ending balance per the Q4 forecast is roughly \$1 million, though there remains substantial uncertainty about the final figure. The Board approves the usage of these one-time resources in the following manners:

- Affirm the set aside of up to \$250,000 to support flexibility in planning future General Assemblies and rebuild the GA reserve
- Restrict the remainder of the FY20 ending balance net GA losses to support implementation of the recommendations of the Commission on Institutional Change
  - This restriction will be a minimum of \$600,000, regardless of the actual ending balance
  - The funds will be used for implementing COIC recommendations above and beyond those expenditures included in the approved FY21 and FY22 operating budgets
  - \$100,000 of restricted funds would be immediately distributed in grants to identity-based organizations

The UUA will report the full ending balance at a future Board meeting. The pandemic's toll has been heavy, especially on those least able to bear its wrath for reasons of health, access to healthcare and financial resources thus it seems appropriate that this financial benefit be reserved to significantly and immediately provide implementation support for the recommendations of the COIC.
