Meeting Minutes

Co-Moderator Du Mond called the meeting to order at 2:05 pm, welcomed Board members to introduce themselves with verbal physical description. Members shared their roles and interests on the Board.

FY2021 Surplus Proposal

Board members reviewed the memo from staff which proposed uses for an anticipated surplus from FY21. The proposal included \$250,000 for staff bonuses, since UUA staff did not receive a cost-of-living adjustment in the past year, and \$100,000 to replenish the Disaster Relief Fund. Members noted the need for a long-term plan for supporting the DRF, given the rising number of disasters related to climate change. Kathy Burek moved, Sherman Logan seconded, and the Board unanimously approved the proposal.

Planning for future meetings

Board members and staff noted their orientations will be scheduled in summer or early fall to give an overall introduction to the UUA, a primer on UUA finances, and an orientation to the Board's own process and decision-making.

For the scheduled October meeting, Board members agreed it was too soon to consider an in-person meeting. They agreed to keep the October meeting virtual, and to revisit during the fall the possibility of planning for in-person meetings.
