Delegates

The Bylaws of the MidAmerica Region of the UUA state that congregations and individual members of the Church of the Larger Fellowship may have the same numbers and kinds of delegates at the Region's Annual Meeting as are permitted at the UUA General Assembly. This includes member delegates in the numbers set out in the UUA Bylaws. In addition, ministers in fellowship serving congregations, credentialed religious educators, credentialed musicians, and those serving as directors of religious education are also eligible to be delegates. Delegate cards in the appropriate numbers will be mailed to congregations in early March, 2020. Delegates must bring their delegate credentials to the Annual Meeting and register for their voting credentials.

Voting materials will be made available on the MidAmerica Region website (www.uua.org/midamerica), and will be emailed to presidents, ministers, religious educators, musicians, administrators, and those registered for Regional Assembly by no later than March 19, 2020.

ANNUAL MEETING FAQS

When should we receive our Delegate Credential Cards? The Delegate Credential Cards should reach your church office shortly after March 19, 2020.

When will delegates receive voting materials? Voting materials will be emailed to all those registered for the Regional Assembly by March 19, 2020. Materials will also be available on the Region website. Because of our commitment to the environment, we will be making a limited number of copies available at the meeting.

How many delegates is each congregation entitled to send to the Annual Meeting? This document contains a list of congregations, sorted alphabetically by state then city, that shows the number of delegates each congregation may send to the Annual Meeting.

Should you believe that the number of delegates is in error, please contact Lisa Presley, Congregational Life Consultant, at lpresley@uua.org, or 248-514-5458.

How is the number of delegates determined? The number of delegates is determined by the MidAmerica Bylaws. For congregational delegates, the numbers are the same that the congregation would be entitled to for General Assembly. Ministers in fellowship serving congregations, affiliated ministers, ministers emeritus/emerita, credentialed religious educators, credentialed musicians, and directors of religious education are afforded delegate status by virtue of their position.

How are membership numbers determined for each congregation? The congregational membership is reported/certified with the UUA in February each year. The number of certified members as reported by February 3, 2020, is used to determine the number of delegates for each congregation for this year's Regional Assembly.

2020 Slate of Nominees

The Nominating Committee of the MidAmerica Region has submitted their <u>slate of candidates</u> for election at the Annual Meeting in Rockford on April 18, 2020.

Under the <u>MidAmerica Region Bylaws</u>, individuals may run by Congregational Action. The Bylaws read:

Article VII. Nominations

"Section 2. **Nominations by Congregational Action.** A member of a congregation in good standing with the Region may be nominated for any position to be elected by formal endorsement of the governing bodies of at least ten (10) congregations within the Region. Nominations by congregational action must be received by the Secretary no fewer than thirty-five (35) days in advance of the Annual Meeting at which the election is to be held."

Any endorsements for an individual who wishes to run must be received by MidAmerica Board Secretary, Dorit Bergen, by no later than March 14, 2020. Ms. Bergen can be reached at midamerica@uua.org.

PROPOSED RULES OF PROCEDURE

Annual Meeting of the MidAmerica Region, UUA

April 18, 2020

Given the situation of the global pandemic concerning Coronavirus and COVID-19 illnesses, we the representatives attending the Annual Meeting of the MidAmerica Region realize that this is not "business as usual," and agree to these relaxed Rules of Procedure, given the exigencies of the situation.

RULE 1. ORDER OF BUSINESS

Consideration of and action upon items must proceed in the order set forth in the Final Agenda unless, during the meeting, that order is changed by majority vote.

RULE 2. PARTICIPATION IN DEBATE

Speakers recognized by the President shall identify themselves by name and congregational affiliation. Participation in debate is limited to delegates. The President may waive this requirement.

RULE 3. MEANS OF VOTING

Action on any question, unless the Bylaws otherwise provide, will proceed by vote of those in attendance. A vote will be called by the President. The required proportion of votes cast by delegates to approve any action or resolution will be as set forth in the Bylaws or these Rules of Procedure. Given the global pandemic, those present have the right to declare to a quorum being present, without an actual tally of all delegates.

RULE 4. PRESENTATION OF ITEMS

The provisions of Rule 5 notwithstanding, the Board will, at its discretion, either move the item as printed on the Final Agenda or move an amended version of the item.

RULE 5. AMENDMENTS

Except for clarifying amendments, amendments to the main motion and motions to refer, table or to call the question will not be in order until there has been at least ten minutes of debate, if that much is needed, on the merits of the main question as moved. No amendment or other change to any motion under consideration will be entertained unless it is submitted in writing. However, the President may waive this requirement.

RULE 6. TIME LIMITS

The following time limits are imposed on all business transacted by the assembly. If, however, there is no objection from the floor, the President may grant minor extensions of time. Any time limits imposed by this rule may be extended by a two-thirds vote.

- a) No person may speak on any motion for more than two minutes, and not more than once, so long as there are others who have not spoken who desire the floor, except that persons having special information may, with the permission of the President, reply to questions.
- b) Twenty minutes is allowed for discussion of any proposed bylaw amendment, rule change, resolution, or action on a report that is on or admitted to the Final Agenda, unless the time limit is extended in the manner provided in the first paragraph of this Rule 6. Whenever possible, the discussion time will be equally divided by proponents and opponents and by the alternate recognition of Pro and Con speakers.
- c) A motion to call the previous question on the main motion shall not be in order if there are potential speakers at both Pro and Con microphones and the original or extended time for discussion has not expired. A motion to call the previous question on a motion to amend the main motion is in order after 8 minutes of discussion concerning the amendment.

RULE 7. COMMITTEE OF THE WHOLE

At any stage of the meeting, the President, without a vote of the assembly, at their discretion from time to time may order the meeting resolved into a Committee of the Whole or reconvened in regular Session. While the meeting is acting as a Committee of the Whole, the following Special Rule will apply: The Presiding Officer, without a vote of the Committee of the Whole, may permit reconsideration of any action taken by the Committee of the Whole, and other departures of the Rules of Parliamentary Procedure if it appears to them that the work of the Committee of the Whole will thereby be expedited. When the assembly is reconvened, the only motion in order will be to adopt the recommendation of the Committee of the Whole. A motion recommended by the Committee of the Whole will not be subject to amendment, debate, or delay.

RULE 8. AMENDING THE RULES OF PROCEDURE

These Rules of Procedure will be adopted by a two-thirds vote and may be amended, suspended, or repealed during the course of the assembly only by a two-thirds vote.

MidAmerica Region, UUA 2019 Business Meeting, April 6, 2019, St. Louis, MO Approved by the Board of Trustees, June 2019

Welcome and Call to Order

President David Lauth called the meeting to order at 10:50 am Central Time with opening words from Rebecca Edmiston-Lange.

Introduction to MidAmerica Region

President Lauth welcomed delegates and other members of the MidAmerica Region to the 6th gathering as a Region. He acknowledged Board Members Tammy Lemmer, Omega Burckhardt, Christopher Sims, Brian Bach and Mitra Jafarzadeh in attendance. He reported that MidAmerica consists of 186 UUA affiliated congregations across 13 states with 28,000 individual members and serving 8,000 children and youth in religious education programs. Ten Congregations have membership over 500 people (making up ¼ of the Region's total membership,) with 129 congregations (79%) with under 150 members, and 51 congregations with under 50 members.

Credentials Report/Certification of Quorum

Secretary Tammy Lemmer affirmed that quorum was met by exceeding the required number of represented congregations (25) located in at least five states. Officially there were 165 total delegates (129 congregational delegates and 36 professional delegates) representing 66 congregations from all 13 states.

Approval of Rules of Procedure

Vice President Mitra Jafarzadeh moved adoption of the Rules of Procedure as distributed to congregations and as appears on the Region's website. Janet Nortrum (First Unitarian Society of Milwaukee, WI) seconded. The motion carried.

Nominating Committee Report and Election

Kay Slama (UU Church of Willmar, MN) reported that she and Bob Lovell (UU Church of Greater Lansing, MI) were selected as Co-Chairs of the Nominating Committee. She presented the report of the Committee, including a review of the outreach and recruitment process and presentation of the proposed slate. She shared her appreciation for the opportunity to serve, and thanked those who have accepted invitations to serve. She noted that the Region had provided space for an information table for those interested in learning more about Regional Leadership.

With no other nominees submitted for consideration, Dale Handeen (UU Church of Willmar, MN) moved adoption of the slate. Susan Cohn (UU Church of Lexington, KY) seconded. The motion carried.

Following the acknowledgement that the Region was meeting on land once belonging to the indigenous Osage, Miami, Sioux and Haudenosauneega (also called Iroquois) tribes, Kay Slama responded to several questions about the Nominating process.

Q. What steps were taken to address white supremacy and bias?

- A. There was a specific request from the Board to focus on increasing diversity. The Committee surveyed sitting members of boards and committees on their identities. They also made contact with various people of color individuals and organizations for recommendations. In looking at available candidates, the committee weighed in favor of increasing diversity.
- Q. What about names that were submitted for consideration that were not included on the slate, especially young adults?
- A. Committee members made attempts to reach all individuals submitted for consideration. Some individuals did not respond. Anyone interested is encouraged to speak with a Committee member or to visit the info table and share their contact information. Younger adult representation is welcomed and encouraged.

President Lauth thanked the Nominating Committee for their service.

Proposed Amendments to the Bylaws of the MidAmerica Region

Secretary Tammy Lemmer described the process the Board launched in the fall to update the bylaws which were originally adopted as part of regionalization. The Nominating Committee in particular had articulated concerns related to filling vacancies. Board members Tammy Lemmer and Kyrie Bock were selected to serve on a Bylaws Workgroup with Kay Slama, Bob Lovell and Kees DeWitt from the Nominating Committee. Feedback was solicited from across the Region.

Proposed changes relate to the election of officers, clarification that Ministers may serve (even if not members of their congregations), clarifying the Camp UniStar appointment process, and adding Nominating Committee vacancy language. T. Lemmer made a motion to adopt the proposed amendments to the MidAmerica Region Bylaws. Helen Dwyer (All Souls Unitarian Church, Indianapolis, IN)

Tammy Lemmer and Kay Slama addressed several questions.

- Q. Did the committee consider institutionalizing attention to anti-racism and multi-culturalism especially in the role of the Nominating Committee?
- A. Inclusivity and diversity are already codified in Article II, Section 4, as well as Article VII, Section 1 e. These principles remain at the forefront of conversations and decision-making.
- Q. What if no one wants to take a position of leadership once elected to the Board? A. There is process language in the bylaws to address identification of leaders and the role of the Board and Nominating Committee. Specific skills and experience will still be sought in the nomination process.
- Q. Is there a way to ensure young adult representation?
- A. The Region could consider a future Bylaw change. However, there is currently and has been young adult representation on the Board since Regionalization.
- Q. Is there concern about filling the position of Treasurer?

A. It is the role of the Nominating Committee to know who is on and coming off the Board. They will continue to identify and recruit people to fill any gaps.

- Q. Should the Region adopt language similar to the UUA bylaws regarding Youth Caucus members?
- A. That could be considered for a future update.
- Q. Could the Treasurer position be made ex-officio to pull in expertise?
- A. That could also be considered.
- Q. Should the Charge from the Board to the Nominating Committee include a request for specific representation (i.e. need for specific experience, young adult.)?
- A. The Board and Nominating Committee take their role very seriously, and the makeup of leadership positions is looked at closely. The Board Charge often does highlight and identify specific gaps. One of the biggest barriers is the response (or lack thereof) from Congregations when the call for nominations goes out.
- Q. What other ways could we codify the commitment to diversity?
- A. Some ideas include updating the nominee questionnaire and referring to the Commission of Institutional Change for suggestions. The Nominating Committee continues to be open to other ideas and values the input of all.

With no additional questions the vote was held and the motion passed unanimously. Tammy Lemmer thanked the committee for their time and efforts.

Expression of Appreciation from our Unitarian Universalist Association Rev. Vail Weller, Congregational Giving Director of the UUA Stewardship & Development Office shared greetings and gratitude from UUA President Rev. Susan Frederick-Gray. Rev. Weller described contributions to the Annual Program Fund (APF) as the way we, as Congregations, make a commitment to each other through financial support for our Association. The mission of the APF is to equip congregations for healthy, vital ministry, to credential and support leaders, and to advance UU values. She thanked the Region for our support for each other and the Association.

Expenditures for the Association rose in the period of 2005-2015. Attainment of APF goals was 73% nationally, but only 62% in MidAmerica. Rev. Weller and Stewardship staff welcome conversations about attaining Honor Congregation status (those contributing their full requested contribution of the end of the fiscal year,) and thanked those that are maintaining and striving to reach that status.

Recognition of Those Completing Their Service to the MidAmerica Region this year Rev. Ian Evison acknowledged staff member Peg Boccard, who is completing her service to MidAmerica.

Nancy Combs-Morgan, Jessica York, and President Lauth honored the work of outgoing Congregational Lead, The Rev. Ian Evison, who was set to retire as of April 20. President Lauth

described Rev. Evison as steady, astute and unflappable, and someone who acknowledges mistakes and strives to make amends.

In his parting words, Rev. Evison thanked his colleagues and the many volunteers he's worked with over the years. He noted it was an honor to serve the Association, even in difficult times. His experience in supporting the Native American Water Protectors at Standing Rock in North Dakota with the Rev. Karen VanFossan has been life changing, and he plans to continue that work.

President Lauth acknowledged the service of outgoing Board Member Omega Burckhardt, who is pursuing ministerial studies. He also noted the passing of former Board Member Janis Cheney, who is greatly missed.

Closing Words

President David Lauth offered closing words from Andrea Hawkins-Kamper on "being about the work."

Adjournment

Iris Kiesling (UU Church of Bloomington, IN) moved for adjournment and Terry Wiggins (First Unitarian Society of Milwaukee, WI) seconded. The motion carried and the meeting was adjourned at 11:57 a.m.

Report on behalf of the MidAmerica Region Board of Trustees

March 10, 2020

Since our last business meeting at Regional Assembly in St. Louis, the MidAmerica Region Board of Trustees has been working to serve our congregations, our Region, and our Unitarian Universalist Association. We met in person last October and will meet again at this Regional Assembly, and we have met via conference call every other month. In addition, individual Board members have been contacting congregations to better understand the needs and successes of our congregations. Information regarding our meetings is available at https://www.uua.org/midamerica/midamerica-board.

I am disappointed to report that four Board members resigned this year before completing their terms, including the people of color who had been serving on the Board. Each situation was unique, but it has certainly been troubling to experience so many resignations. As a principal goal this year, we have continued to work individually and collectively as a Board to be better able to advance the cause of dismantling a white supremacy culture. We continue to model a shared leadership process, with a different Board member chairing each month's call. As a group, we have been reading and discussing this year's UUA Common Read, *An Indigenous Peoples' History of the United States*. We have also discussed, updated, and adopted an explicit covenant about how we commit to being in relationship with each other.

We have welcomed Rev. David Pyle as the new lead of our Regional staff. He and our other staff members have been working diligently to support our congregations and build our faith. We are grateful for their dedicated and tireless service to the Region.

None of our Region's work would be possible without the generous support we receive from MidAmerica congregations. We appreciate all of that support, especially that of our Honor Congregations, as well as the support of individuals who have contributed to the Friends of MidAmerica.

I want to acknowledge the service of Kyrie Bock, who will be leaving the Board in June after serving two full terms. We appreciate her many contributions to the Board.

Thank you for allowing me the privilege of serving in this role, and for everything that you and your congregations do to nurture and advance our saving faith throughout MidAmerica.

MidAmerica Regional Lead's Report to the MidAmerica Regional Assembly March 12, 2020

Since September, I have had the honor of returning to the MidAmerica Region as a member of the UUA Congregational Life Staff, and to working with the wonderful Religious and Administrative Professionals of the MidAmerica Region. When I was asked in my interview process to become the MidAmerica Regional Lead why I wished to serve in this role, I named two things... my experience serving as a minister in congregations of the MidAmerica Region, and my desire to serve our faith movement with the amazing staff of MidAmerica Region. I wanted to serve with Nancy Combs-Morgan, Sharon Dittmar, Andrew Zallar, Cameron Young, Phil Lund, Lisa Presley, Kathy Charles, Gretchen Ohmann, Katie Phillips, Christine Purcell, and all of the Adjunct Consultants, who together serve the congregations of MidAmerica. While I am not, and will never be my beloved friend and mentor, Ian Evison, it has been a joy to move into the role of Regional Lead and Congregational Life Consultant with this amazing staff. While we may be fewer in number than any other Regional Staff in our Association, the skill, dedication, wisdom, and humor of this team make that sometimes easy to forget.

I also wish to celebrate the work of the MidAmerica Regional Board, as we look closely at the future of the Region in the changing environment of our faith. I have never seen a Board look more deeply at their own assumptions and interactions, seeking to find the way towards the Beloved Community. These wonderful Leaders of our religious movement have dedicated their time, their talents, and their hearts to inspire the Region to live up to our shared values, to ask necessary and sometimes difficult questions, and to helping me not only to integrate, but to let go of being the "Executive" in a Policy Governance system that became ingrained in me when I was a District Executive, and to move into a governance partnership based on relationship and trust.

I also wish to thank all of the Lay Leaders and Religious Professionals who volunteer of their time and talent as Regional Adjunct Consultants, as members of the Nominating Committee, as staff and leadership for our two Leadership Schools, as volunteers in Regional programming, and as partners in the work of building a healthy and vibrant Unitarian Universalism throughout the MidAmerica Region.

There are some significant questions before the Board and the Regional Staff through this year and into next. One of the transitions of this year involved the integration into the Regional Budget of approximately \$32,000 of new staffing costs in order to support the shared staffing relationships between the MidAmerica Region and the other Regions of our UUA. For the last several years, the MidAmerica Region has benefited from the support of sharing Faith Development, Youth Ministry, and Events Planning staffing with the Southern Region, with significant amounts of the costs of that shared staffing delayed until this year. Also, the MidAmerica Region joined with the other five Regions of our UUA to create a national Transitions Program Manager position, to provide

consistent support to all of our congregations in ministerial search. The integration of these costs this year into the Regional Budget is the reason why your MidAmerica Board approved a deficit budget for next fiscal year. We are grateful to the other Regions of our UUA that have carried the burden of these costs on our behalf these last few years, and it is time for us to integrate those costs into our own budget. A deficit budget is not something we can continue, and so your Regional Staff and your Board are exploring several paths to eliminate this deficit through a fuller integration with our UUA.

But it is not numbers that tell the story of the MidAmerica Region this year... it is you. Our story is told by our two new UU Congregations this year, the Lakeshore Unitarian Universalist Fellowship in Manitowoc, Wisconsin, and the Mt. Vernon Unitarian Universalist Fellowship in Mt. Vernon, Illinois. Our story is told by the Unitarian Universalist Church, in Rockford Illinois, who volunteered their spiritual home not just to host this Regional Assembly, but also to host two gatherings of Religious Professionals, a gathering of UU Social Justice activists hosted by the UU Advocacy Network of Illinois, a Board and Staff Meeting of the MidAmerica Region, and a Get-Out-The-Vote Training by UU the Vote... all in the same weekend! That we needed to shift these events to an online format due to the pandemic in our nation does nothing to lessen the generosity of heart and the living of the covenant of our faith that the Rockford UU's had committed to, and we thank them from the depths of our hearts.

Our story is told by the Faithify campaigns that our congregations have put forward in the past year, and the ways UU's and our own Chalice Lighter Program have helped to fund those campaigns for new staff, youth programming, building expansions and modernizations, our work for Justice, Ordinations, Installations, Retirements, and Internships for Religious Professionals, and so, so much more.

Our story is told by the generosity of our congregations in supporting the Annual Program Fund of the UUA, which funds all of the work of your Regional and National Association Staff and Programs. Every webinar you have attended, every workshop, every phone call with or visit from a Congregational Life Consultant, every good idea or program that you find in your email, every curriculum for faith development, every book from Skinner House, every minister, religious educator, or professional musician who receives fellowship or credentialing, every effort for to build the Beloved Community through the justice programs of our association... all of this and more is funded through your congregation's gifts to the Annual Program Fund of our Association.

Our story is told by the difficult work of looking at ourselves, to see where the cultural assumptions of ourselves, our congregations, our Region, and our Association prevent us from living the Beloved Community and cause us to foster harm to those who hold identities outside of the white dominated and cis-gender dominated cultural paradigms of our country. In seeking to dismantle white supremacy culture in ourselves, in our congregations, in our Region, and in our Association, we seek to lay the foundation and learn how we might, one day, dismantle the white supremacy culture that is endemic to

our country. That work is hard, and not everyone is in the same place in that work at the same time. For some, the changes and the challenging of assumptions appear to be happening so fast that it causes fear and resentment. For others, especially those who have been wounded by the cultural assumptions that privilege the white and the cis-gendered in our movement and in society, the changes and the challenging of assumptions have not come soon enough to prevent the harms they have experienced.

We, your Regional Staff, remain committed to continuing this work of dismantling these cultural assumptions that cause real and ongoing harm, in our own lives and in our work within our shared faith. We also are committed to supporting you and your congregations as you seek to challenge and change those cultural assumptions that privilege dominate culture in our congregations and in our country.

This is our story, and it is one that we tell together. I am honored that I get to tell that story with you.

Report of the Nominating Committee

MidAmerica Region of the Unitarian Universalist Association

April 18, 2020

The Nominating Committee is pleased to present eleven highly qualified, enthusiastic candidates to you today. We began our work last April, staffing an information table at the Regional Assembly. This allowed delegates and visitors to learn about elected governance in the Region, and a few folks indicated interest in serving in the future. We began with these candidates and candidates from last year who indicated that they might be interested later. Regional staff, particularly Andrew Zallar, assisted us in setting up Internet video meetings and in twice canvassing the Region's congregational lay leaders and ministers by email, asking for nomination suggestions. Notices were also placed in the MidAmerica Messenger asking anyone interested to contact us. The result is the slate we present today. In addition to their qualifications and enthusiasm, these nominees, if elected, will provide viewpoints diverse in age, gender, sexual orientation, UU experiences, professional skills, and location. In short, we are proud of our work.

Our work this year was greatly simplified by your vote last year changing the bylaws to provide for election of Board officers by the Board, rather than by the delegates at the Regional Assembly. Thank you!

We worked to improve our process this year. We have expanded and emphasized our candidate tracking table. We are again staffing an information table at this assembly, and we invite you to drop by for discussion and recommendations. We have created a database to track Board and committee members' appointments, elections and term and service eligibility to help us comply with the by-law changes made last year. The committee shares and archives documents through a Dropbox file with common access. We have a small budget allocation and we expect to spend it on a professionally-led diversity seminar when our new members take office this summer.

Still, despite these efforts, a serious problem has arisen. None of the three persons of color on the Board chose to continue their service, and the Nominating Committee also will lose both of the persons of color who worked with us this year. We received no recommendations or applications for candidates who identified as persons of color. Thus, none of the nominees on the slate recommended to you today identified as a person of color, and there are no incumbent persons of color.

The Board recognized what was happening to its makeup and asked us to concentrate on nominating persons of color. Departures from the Nominating Committee became evident only late in the process, but we were aware of them before making our final recommendations. The reasons for the departures vary widely, so more than one remedy will be needed.

Representation of persons of color in our leadership is an important, ongoing goal. Nothing can substitute for having their lived experience in our leadership. Unitarian Universalism is having a denomination-wide debate about how and sometimes if we can collectively and effectively combat white supremacy. And yet, we must recognize that asking persons of color to deeply engage with these discussions from leadership positions is asking for a significant amount of unpaid emotional labor. The Nominating Committee is more than willing to consider and promote the inclusion of people who choose to take that on, regardless of color.

2018/2019 Annual Report to the MidAmerica Region & the Mountain Desert District

Midwest Unitarian Universalist Conference

History: With the consolidation of the American Unitarian Association (AUA) and the Universalist Church of America (UCA) in 1961, the Midwest Universalist Conference and the Western Unitarian Conference formed the Midwestern Unitarian Universalist Conference (Conference) and the Midwest Unitarian Universalist Foundation (Foundation).

Purpose: The purpose of the Conference is to further the interests of Unitarian Universalists and their institutions in the mid-continental states (i.e., MidAmerica Region and the Mountain Desert District); to support those institutions to spread the message of Unitarian Universalism; and to distribute returns generated by funds held in trust by the Foundation, a subsidiary corporation. The purpose of the Foundation is to hold those funds received from the AUA, UCA, and other sources in trust, and to invest, administer, and safeguard those funds.

Funds: There are four funds for which the Conference and the Foundation are responsible:

- > the General Fund, which provides an annual grant to the MidAmerica Region and the Mountain Desert District, and which can fund other initiatives;
- > the Ryder Fund (1888): the income is used to provide emergency financial support for retired ministers and their partners;
- the Iva Laughlin Fund (1903): the income is used to provide emergency financial support for elderly Unitarian Universalists; and
- > the Colchester Fund (1926): the income is used to provide an annual scholarship that is awarded by Meadville Lombard Theological School in Chicago to a Unitarian Universalist theological student; and

Since June 2016, the MidAmerica Region has been the fiscal agent for the Midwest Unitarian Universalist Conference. This role is limited to holding funds distributed from the Midwest Unitarian Universalist Foundation related to the Ryder, Laughlin, and Colchester Funds, as well as limited funds to support small grants, such as those of the Munroe Husbands Grant Program, which provides grants to lay-led congregations for leadership development, communications tools for outreach, growth, and related matters.

The Conference Board has developed materials to publicize the funds available from the Ryder Fund, the Iva Laughlin Fund, and the Munroe Husbands Grant Program. The Board also sends money from the Ryder Fund to the UUA for distribution to retired

ministers and their partners through the work of the Rev. Richard Nugent, Church Staff Finances Director consistent with the guidelines of the Ryder Fund.

All Grant Program applications can be found on the Conference/Foundation website. (http://www.midwestuuconf.org/) Work on the website has continued this year, thanks to Barb Gutsch, a MUUC Board Member, who serves as the Webmaster.

Committees: The Conference has several working committees: The Nominating Committee, the Colchester Fund Committee, the Laughlin Fund Committee, the Ryder Fund Committee, and the Munroe Husbands Grant Program Committee.

A distribution in the amount of \$5.341 from the Colchester Fund was sent to Meadville Lombard Theological School this year. This money was awarded to a theological student as the Colchester Scholarship for the current academic year.

The following grants were also awarded this fiscal year: From the Ryder Fund \$4,198; from the Laughlin Fund \$1,000; and from the Munroe Husbands Grant Program \$8,007.50.

Other Business: Besides the distribution of monies, the MUUC Board voted to change its name to coincide with the Foundation. We voted to change Midwestern Unitarian Universalist Conference to Midwest Unitarian Universalist Conference. Plus, we are currently reviewing our by-laws, and will vote on changes at our annual meeting in May of 2020.

Interim Meetings: The Conference directors and the Foundation directors work separately during the year via quarterly tele-conference.

Annual Meeting: The Boards of the Midwest UU Conference and the Midwest UU Foundation hold our annual meeting in Chicago in early May, where we meet separately and jointly. The 2019 meeting was held on May 3-4, 2019. (Note: The 2020 meeting will be held May 1-2.)

Distribution from the General Fund: Part of the agenda at the Annual Meeting was to determine the annual grants for 2018-2019 to the MidAmerica Region and the Mountain Desert District. These grants are based on a formula that takes into account the number of congregation members (weight = 45%), the number of congregations (weight = 45%), and the geographical size (weight = 10%) of the region or district. The number of members and congregations was based upon UUA certification data as of February 1, 2019.

The maximum amount available for distribution is 4% of a rolling 13-quarter moving average of the Foundation's General Fund. The distribution for 2018-2019 is as follows: \$76,350 to the MidAmerica Region and \$20,959 to the Mountain Desert District. MUUC also set aside \$10,000 for the Munroe Husbands Grant Program, which was used to develop a new lay-led website (http://uulayledcong.org/index.html).

MidAmerica Region and Mountain Desert District Requirements

Please note that the Midwest Unitarian Universalist Conference requires an annual report from both the MidAmerica Region and the Mountain Desert District to confirm that the work of these two organizations continue to be aligned with the purposes of the Conference which are listed above, and Conference's interests which are as follows:

- > Section 1a. To facilitate the vitality and growth of Unitarian Universalism in the Midwest and Rocky Mountain states (i.e. Mid-America Region and the Mountain Desert District).
- > Section 1b. To strengthen Unitarian Universalist congregations, districts, regions and organizations and institutions, including the Unitarian Universalist Association and Meadville-Lombard Theological School.
- > Section 1c. To invite congregations to effectively serve the communities in which they are located in accord with their mission and the principles, purposes, and ends of the Unitarian Universalist Association.
- > Section 1d. To encourage outreach and support of Unitarian Universalists living in the Midwest and Rocky Mountain states who do not live in communities served by Unitarian Universalist congregations.

Midwest Unitarian Universalist Foundation

The fiscal year is from April 1 to March 31. The total assets of the Foundation have grown from about \$200,000 in 1962 to \$3,300,965 as of March 31, 2019.

The financial statements are audited annually. The auditor of record for a number of vears continues to be Wilkerson, Guthmann, and Johnson, Ltd. of Saint Paul, Minnesota. The audit report, determined that the financial statements of the Midwest Unitarian Universalist Foundation presented fairly, in all material respects, its financial position, and the changes in its net assets and cash flows in accordance with accounting principles generally accepted in the United States of America.

The Foundation assets are invested in a variety of mutual funds and exchange traded funds which provide investment diversity. The Foundation determines its asset allocation each year and currently strives for a 70/30 allocation between equity and fixed income. The Foundation also is very sensitive to keeping investment expenses as low as possible while seeking reasonable returns.
