Human Rights Day takes place on December 10 each year, inviting us all to reflect on the state of human rights in the world. It marks the anniversary of the UN's adoption of the Universal Declaration of Human Rights, written in 1948 (in part by Canadian Unitarian John Peters Humphrey) to acknowledge the set of rights that every human being possesses no matter their place or status of birth, in order that those rights be respected, protected, and fulfilled. The Unitarian Universalist Association Office at the United Nations is part of an important network of non-governmental organizations working on human rights issues at the UN: the NGO Committee on Human Rights, of which UU@UN Director Bruce Knotts is co-chair. In honor of Human Rights Day this year, the UU@UN is hosting an event on December 15 looking into police policies through a global human rights lens that considers race, gender, age, and ability. Congregations are invited to celebrate Human Rights Day by holding a conversation using the UUA International Office's Human Rights Discussion guide. Omicron - The emergence of the threatening new Omicron variant shows how important it is for the world to end the current “cycle of panic and neglect” over the COVID-19 pandemic, said the head of the World Health Organization (WHO) on Monday. The World Health Assembly meeting is convened now in Geneva to decide on the issue of a so-called “pandemic treaty.” Dr. Tedros Adhanom Ghebreyesus has said that [vaccine inequity, among other challenges, has facilitated the appearance of new highly mutated variants](#) such as Omicron.

COP26 Outcome - Of the many agreements and initiatives announced at the 26th UN Climate Conference (COP26) in Glasgow, the UN Climate Communications Lead at the Department of Global Communications narrowed down the three that she deemed most impactful. In an exclusive interview with UN News, Martina Donlon acknowledged that after two weeks of tough negotiations, the text that serves as the conference's outcome is “a compromise that is [not enough,](#)” [especially for small island States and other vulnerable countries.](#) However, it does provide some “positive steps forward.”

Ethiopia - The number of people in need of humanitarian food assistance across northern Ethiopia has spiked as a direct result of ongoing conflict, according to the United Nations World Food Programme (WFP). Of the people across northern Ethiopia in need of assistance, more than 80 per cent - 7.8 million - “are behind battle lines.” Corridors into Tigray had been closed due to the recent Tigrayan advances into Afar and Amhara, as well as severe disruptions linked to federal government approvals. The WFP spokesperson pointed out that this has meant that [less than a third of the supplies needed have entered the region since mid-July.](#)

Trafficking - The COVID-19 pandemic has exacerbated factors that fuel human trafficking such as poverty, unemployment and gender-based violence, the President of the UN General Assembly said on Monday, urging countries to boost efforts to prevent and respond to this “vile crime”. Abdulla Shahid was speaking at the opening of a two-day high-level meeting to [review progress in implementing the UN Global Plan of Action to Combat Trafficking in Persons,](#) adopted by the General Assembly in July 2010.
