## UU Church Partnering in a Dialogue on Race

On April 9, members of Abraham Lincoln UU Congregation in Springfield, Illinois, marched through the streets of Springfield with members of Calvary Missionary Baptist Church, ringing bells as they walked, "to remember the unfulfilled promises that date back to the end of the [Civil] war, promises that were thwarted during Reconstruction and still remain unfulfilled - a full one hundred and fifty years later." \* April 9, 2015, was the 150th anniversary of the meeting to set the terms of surrender of Robert E. Lee's army in Virginia.

The march was an outgrowth of a dialogue on race developed over the past year between the two congregations. The relationship stemmed from concerns that segregation was still an issue in Springfield, according to a public radio program which aired on May 4. Rev. Martin Woulfe, minister at the UU congregation, which is mostly white, partnered with Reverend Silas Johnson of Calvary, a black church, to begin the dialogue.

## Learning Network Covenant Process Begins!

At our MidAmerica Annual Business Meeting at Regional Assembly, our delegates voted overwhelmingly to endorse the Learning Network Covenant (LNC) proposal! The LNC is an open and inclusive Regional visioning process that MidAmerica will undertake over the next two years. The MidAmerica Board hopes that you and your congregation -- or other UU organization -- will join us in this process!

To plan and coordinate the LNC process, the MidAmerica Board has begun to form a Learning Network Covenant Task Force. At its meeting on May 16th, the Board approved a charge for the task force. The Board is currently confirming the task force membership, which will include UUs reflecting the range and depth of UU experience, insight, and relationships present across MidAmerica.
