At our MidAmerica Region Annual Business Meeting in April, delegates overwhelmingly endorsed the Learning Network Covenant -- an open and inclusive visioning process intended to help us explore the possibilities that our new region can engage. Here's a quick update to keep you informed about the Learning Network Covenant process.



In May, the MidAmerica Region Board established a task force to design and coordinate this collaborative process. While the task force in still in development, I'm excited to report that these MidAmerica leaders have agreed to serve on the task force:

#### Ferguson - One Year Later

What can one say about Ferguson? Never enough, never enough, for some of us, and while for others, even one mention of the name is too much. There is much that swirls in the air these days about how we, as a country, respond to the continuing existence of racism in our institutions, our hearts, and our minds. It was with this in mind that I went as part of our MidAmerica contingent to the events marking the one year anniversary of the death (murder) of Michael Brown.

Why did I go? Although I was involved as much as someone of my age could be in the Civil Rights

movement of the 1960s, I left the States early in the 1970s for Canada. There the "complexion" of race relations is not the same-it's based on a different history, and racism in Canada comes from similar but different strands.

So when I returned to the States in the 1990s, I was playing catch up on issues around race. I noticed that some things had changed (many for the better), but that the great divide still existed with regard to education, employment, justice, and how people socialize. I wanted to learn more about that, and so I dabbled in the topic for years. Since coming on staff for MidAmerica, the trainings



have deepened, and I am pleased to be able to work on intercultural competency issues for our Region...

### **UUA Board Welcomes Covenanting Communities**

Several groups in the MidAmerica Region were recognized at this year's General Assembly in Portland, Oregon, as "Covenanting Communities," a new status offered by the UUA Board of Trustees to acknowledge a group's relationship with the wider UU movement. Up until this year, the only way for a dedicated group of Unitarian Universalists to become an official part of the UUA was through the traditional process of congregational affiliation. This new designation makes room for a variety of communities to be part of our association.

According to Carey McDonald, UUA Director of Outreach, "A covenanting community is NOT a member congregation of the UUA, nor is it an interest or affinity group of UUs who are already members of congregations. Covenanting communities are the primary ways that their members or participants connect to Unitarian Universalism."

Groups interested in the Covenanting Community status had to submit an application that included their community's answers to these questions:

- How do you claim UU identity and principles?
- How do you advance UU values in the world?
- What relationships do you have with other UU congregations, groups, organizations, etc.?
- What are your covenanting practices or documents?

In addition, groups made a financial pledge to the UUA appropriate to their size and means.

Of the 11 communities welcomed by the UUA Board of Trustees in Portland, three are part of the MidAmerica Region:
