MidAmerica Region Staff

The MidAmerica Region is looking for a full-time Regional Administrator. This person is responsible for communications, event registrations, logistics for meetings, and assists with financial matters. This person also takes on projects for the Region, and works in collaboration with other administrative staff across the Regions and the UUA. The Administrator works on a team



with other regional administrative staff, under the supervision of one of our program staff. Ability to work in a technological and online environment, ability to handle multiple deadlines, manage projects, and work with numbers is essential. They also supervise part-time casual employees, when appropriate.

This person, like the rest of our staff, works from a home office, and must be able to function well in the virtual world, and be self-starting and motivating. There is occasional travel, both local and to Regional Assembly and semi-annual staff meetings. The job description will be posted on our web site no later than March 15. Applications will be taken until the job is filled. The interview process will begin early in April, so applicants are encouraged to submit their resumes early. The position begins sometime after May 1, with the date to be determined by mutual consent. The Region strives to be a great place to work, and we are an Equal Opportunity Employer. Our staff work from their homes. Computer equipment is provided. Stipends are given for cell phone service and internet service, but not for other expenses for working from home.

What is a MidAmerica UU Role in the Era of President Trump?

On Saturday, January 21, 2017 at 8 a.m., I got on the Washington D.C. Metro with my brother-in-law and husband to attend the Women's March on Washington. I had been working with MidAmerica UU congregations in Minnesota, Michigan, and Missouri who were sending buses to the march. (Can you say driving overnight!!) We had all agreed to meet at a "UU Meet Up" prior to the march. It was so crowded we never found each other. However, I did find other MidAmerica Unitarian Universalists from First Unitarian Church in Cincinnati and Heritage Universalist Unitarian (Cincinnati), as well as a variety of UUs from Virginia, Maryland, and Washington, D.C.I have been attending marches for over 25 years. I have never been to one so big. And certainly, never to one so energized, friendly, and creative. I met people from all over the United States. And even though we were at times packed in like sardines, people were



relentlessly helpful and friendly, from the protesters, to the police, to the National Guard.

I went to this march to assist our MidAmerica congregations, and stay involved in issues that are of importance to our congregations. However, I am also well aware that not all Unitarian Universalists agreed with the march. As someone pointed out to me long ago, our Principles can contradict one another. It is not always easy to balance a "free and responsible search for meaning" and "acceptance of one another and encouragement to spiritual growth." We don't all

see the same things the same way. There are Unitarian Universalists who voted for Donald Trump, Hilary Clinton, Gary Johnson, and Jill Stein. And knowing us, we probably wrote in a few candidates as well.

The march was deeply moving. I came back energized and hopeful. I also returned with questions: "What is the unique way each congregation will respond?" "What are the theologies that support us in our work?" "What do we have to learn from people who do not agree with us?" "In an anxious political climate, how can our congregations remain loving, pro-active, and well-differentiated?"

Our journey is just beginning. I look forward to joining all of you in learning along the way.

Please share this application with youth you've worked with, graduates of leadership schools, and congregational leaders. Please let them know that after they apply, if accepted, there is a short campaign season (two weeks) and then they will know in time to register for General Assembly. Youth Observers have all of the rights and responsibilities of UUA Board members including having to be a member of a congregation, but do not get to vote on UUA business according to current rules. The youth observers do have a voice at the table. In case it comes up, my current understanding is that other by-laws pertaining to Board membership do not apply to the youth observers, because the YOs are not mentioned in the by-laws.

Every summer, about 75 adults and high-school youth come together for a week-long experience of leadership development grounded in our Unitarian Universalist faith. MidWest Leadership School has been an inspiration to a lifetime of service for many of the participants over the past 30 years. It is an intense and exciting week for all who participate-a week where spiritual growth is nurtured and lifelong friendships are formed.

While the adult school and the youth school have separate curriculum and staff, both groups come together every day to plan and participate in worship services. As a result of these intergenerational planning opportunities, all the participants go home to their congregations with a commitment to bringing youth and adults together to serve their faith communities. This summer, MidWest Leadership School moves from its long-time Beloit College home to a new location - Luther College in Decorah, lowa. The Luther campus is modern, accessible, and beautiful.
