Proposed Rules of Procedure

RULE 1. ORDER OF BUSINESS

Consideration of and action upon items must proceed in the order set forth in the Final Agenda unless, during the meeting, that order is changed by majority vote.

RULE 2. PARTICIPATION IN DEBATE

Speakers recognized by the President shall identify themselves by name and congregational affiliation. Participation in debate is limited to delegates. The President may waive this requirement.

RULE 3. MEANS OF VOTING

So long as a quorum is present, action on any question, unless the Bylaws otherwise provide, will proceed by vote of the delegates. A vote will be called by the President. The required proportion of votes cast by delegates to approve any action or resolution will be as set forth in the Bylaws or these Rules of Procedure.

RULE 4. PRESENTATION OF ITEMS

The provisions of Rule 5 notwithstanding, the Board will, at its discretion, either move the item as printed on the Final Agenda or move an amended version of the item.

RULE 5. AMENDMENTS

Except for clarifying amendments, amendments to the main motion and motions to refer, table or to call the question will not be in order until there has been at least ten minutes of debate, if that much is needed, on the merits of the main question as moved. No amendment or other change to any motion under consideration will be entertained unless it is submitted in writing. However, the President may waive this requirement.

RULE 6. TIME LIMITS

The following time limits are imposed on all business transacted by the assembly. If, however, there is no objection from the floor, the President may grant minor extensions of time. Any time limits imposed by this rule may be extended by a two-thirds vote.

No person may speak on any motion for more than two minutes, and not more than once, so long as there are others who have not spoken who desire the floor, except that persons having special information may, with the permission of the President, reply to questions.

Twenty minutes is allowed for discussion of any proposed bylaw amendment, rule change, resolution, or action on a report that is on or admitted to the Final Agenda,

unless the time limit is extended in the manner provided in the first paragraph of this Rule 6. Whenever possible, the discussion time will be equally divided by proponents and opponents and by the alternate recognition of Pro and Con speakers.

A motion to call the previous question on the main motion shall not be in order if there are potential speakers at both Pro and Con microphones and the original or extended time for discussion has not expired. A motion to call the previous question on a motion to amend the main motion is in order after 8 minutes of discussion concerning the amendment.

RULE 7. COMMITTEE OF THE WHOLE

At any stage of the meeting, the President, without a vote of the assembly, at his or her discretion from time to time may order the meeting resolved into a Committee of the Whole or reconvened in regular Session. While the meeting is acting as a Committee of the Whole, the following Special Rule will apply: The Presiding Officer, without a vote of the Committee of the Whole, may permit reconsideration of any action taken by the Committee of the Whole, and other departures of the Rules of Parliamentary Procedure if it appears to him or her that the work of the Committee of the Whole will thereby be expedited. When the assembly is reconvened, the only motion in order will be to adopt the recommendation of the Committee of the Whole. A motion recommended by the Committee of the Whole will not be subject to amendment, debate, or delay.

RULE 8. AMENDING THE RULES OF PROCEDURE

These Rules of Procedure will be adopted by a two-thirds vote and may be amended, suspended, or repealed during the course of the assembly only by a two-thirds vote.

MidAmerica Region, UUA 2018 Business Meeting, June 20, 2018, Kansas City, MO Approved by the Board of Trustees, July 2018

Welcome

President Eric Huffer welcomed delegates and other members of the MidAmerica Region. He acknowledged Regional Staff Ian Evison, Sharon Dittmar, Nancy Combs-Morgan, Phil Lund, Lisa Presley, and Andrew Zallar and Board Members David Lauth, Tammy Lemmer, and Mitra Jafarzadeh in attendance.

Call to Order

President Eric Huffer called the meeting to order at 4:35 pm Central Time and invited those in attendance to join him in reciting the Purpose of the MidAmerica Region.

Credentials Report/Certification of Quorum

Secretary Tammy Lemmer affirmed that quorum was met by exceeding the required number of represented congregations (25) located in at least five states. Officially there were 153 delegates representing 61 congregations across 11 states.

Approval of Rules of Procedure

Vice President David Lauth moved adoption of the Rules of Procedure as distributed to congregations and as appears on the Region's website. Dorit Bergen (1st Unitarian Society of Madison) seconded. The motion carried.

Nominating Committee Report

Committee Member Bob Lovell (UU Church of Greater Lansing) presented the report of the Nominating Committee, including a review of the outreach and recruitment process and presentation of the proposed slate. Some challenges were noted, and the slate contains one remaining vacancy for the Nominating Committee. Mr. Lovell extended appreciation to Regional staff for their assistance, as well as current, exiting and incoming members of both the Board and Nominating Committee for their service.

With no other nominees submitted for consideration, Joan Pederson (1st Unitarian Society of Chicago) moved adoption of the slate. LauraLee Woodruff (1st Unitarian Church of Lincoln, NE) seconded. The motion carried.

Expression of Appreciation from our Unitarian Universalist Association

Rev. Vail Weller, Congregational Giving Director of the UUA Stewardship & Development Office shared greetings and gratitude from UUA President Rev. Susan Frederick-Gray. Rev. Weller described contributions to the Annual Program Fund as a

fulfillment of a promise to be in community with the denomination as a whole, and shared statistics on levels of giving to the UUA and Region. She also provided information on the proposed new formula for calculating the APF requests to congregations. The UUA plans to mail packets to congregations in early fall with general information, followed by an individualized congregational letter with the specific calculations. She noted that volunteers from the Generosity Project, including MidAmerica's Michele Grove, are available to help connect with congregations.

Recognition of Those Completing Their Service to the MidAmerica Region this year

President Huffer acknowledged the dedication and service of outgoing Board Members Janis Cheney and Doug Cauble. Vice President Lauth expressed similar appreciation for President Huffer, who was completing his 2nd term on the Board after having served on the very first Regional Nominating Committee. Tokens of appreciation were distributed for new and departing members.

Closing Words

David Lauth offered appreciation to those in attendance and offered the following closing words: "It is for today, and for times we shall never see. So let us be about the task."

Adjournment

Christine Starr-Davis (UU Church of Lincoln, NE) moved for adjournment and Susan Cohn (UU Church of Lexington, KY) seconded. The motion carried and the meeting was adjourned at 5:15 p.m.

Section 3. Qualifications and Limitations for Election. Each member of the Regional Board and each member of the Nominating Committee shall be a member in good standing of one of the member congregations of the Region, **BE A**MINISTER SERVING A MIDAMERICA CONGREGATION, or be a CLF member residing within MidAmerica geography. If someone is a member of both CLF and a MidAmerica congregation, for the purpose of this section their membership will be deemed to be in the congregation physically located in MidAmerica. The Board of Trustees and the Nominating Committees, together, shall not have more than two (2) members from the same congregation serving at the same time. No person shall simultaneously hold more than one elected position.

Clarifies the eligibility of ministers who are not members of the congregations they serve to be elected to the Board.

Article VII.

Nominations

Section 1. A Nominating Committee shall consist of seven (7) persons. The committee shall elect its own chair no later than August 31st of each year.

- (a) The seven (7) members of the Nominating Committee shall serve terms of two (2) years. In even years four (4) members will be elected by delegates at the MidAmerica Region Annual Meeting; in odd years three (3) members will be elected at the Annual Meeting. Members will serve no more than 3 consecutive 2 year terms
- (b) The Nominating Committee shall nominate at least one person for each open position on the Regional Board and for each open position on the Nominating Committee.
- (c) The Nominating Committee will nominate members for open positions on the Midwestern Unitarian Universalist Conference board each year, in accordance with MUUC's governing documents.
- (d) The report of the Nominating Committee shall be submitted to the Secretary not less than sixty (60) days prior to the annual meeting. The Secretary shall publish the report of the committee and distribute it to member congregations not less than thirty (30) days before the Annual Meeting.

Article IX.

Special Relationships to Other Organizations

Section 1. Camp UniStar Foundation (CUF). The MidAmerica Region is the sole corporate member of the Camp UniStar Foundation. The membership rights of the MidAmerica Region are described in the CUF bylaws. Three of the seven voting members of the CUF Board are appointed by the MidAmerica Region Board UPON RECOMMENDATION OF THE NOMINATING COMMITTEE. Such appointments shall follow the guidelines expressed in the Article titled "Nominations" of these bylaws. These Directors shall meet with the MidAmerica Regional Deletes obsolete Board upon request and provide a written report for distribution at language designed to the Annual Business Meeting of the Region. MidAmerica Directors shall serve a term of three (3) years. Appointments shall from Districts to be so arranged that approximately one-third of the total number of MidAmerica CUF Directors are elected each year. The MidAmerica Board will appoint the first three MidAmerica Directors of the CUF Board to staggered terms no later than September 1, 2013.

Report on behalf of the MidAmerica Region Board of Trustees

February 28, 2019

Since our last business meeting at General Assembly in Kansas City, the MidAmerica Region Board of Trustees has been working diligently to serve our congregations, our Region, and our Unitarian Universalist Association. We met in person last August and will meet again at this Regional Assembly, and we have met via conference call every other month this year. In addition, individual Board members have been contacting congregations to better understand the needs and successes of our congregations. Information regarding our meetings is available at https://www.uua.org/midamerica/midamerica-board.

Our principal goal this year has been to work individually and collectively as a Board to be better able to advance the cause of dismantling a white supremacy culture. To that end, each member completed an Intercultural Development Inventory assessment, with a commitment to attend to what the assessment revealed. We changed our Board meeting practices to model a shared leadership process, with a different Board member chairing each month's call. As a group, we have been reading and discussing this year's UUA Common Read (*Justice on Earth: People of Faith Working at the Intersections of Race, Class, and Environment*, edited by MidAmerica ministers Manish Mishra-Marzetti and Jennifer Nordstrom). We each agreed to participate in a microaction and share that experience with the Board. We also committed to bring this lens to all of our other work.

We worked this year with the UUA's Stewardship and Development staff to implement the "new" Annual Program Fund throughout MidAmerica. Rather than receiving separate requests for financial support from the UUA and the Region each year, calculated on a dollar basis per member, congregations will now receive one unified request, calculated as a percentage of qualifying expenses. We believe this is a more equitable and sustainable model, and we appreciate all of the UUA and MidAmerica staff work that has gone into making it a reality.

Speaking of financial support, none of our Region's work would be possible without the generous support we receive from MidAmerica congregations. We appreciate all of that support, especially that of our Honor Congregations, as well as the support of individuals who have contributed to the Friends of MidAmerica.

We are in a time of transition in our staff leadership. We recently welcomed Jessica York, the UUA's new Director of Congregational Life, and we look forward to working with her. We also bid a reluctant but fond farewell to our staff lead Ian Evison, who will be retiring shortly after Regional Assembly. Ian has contributed enormously to the formation and work of our Region, and we will miss his leadership. We also want to express our gratitude to Peggy Boccard, a long-serving member of our administrative staff who will be stepping down at the end of this church year.

Finally, I want to honor the memory of our dear friend and former Board member Janis Cheney, who died in January after a long illness. Janis was a longtime member of the Bismarck-Mandan Unitarian Universalist Congregation in North Dakota, and she brought her wisdom, her considerable skills, and her grounded and steadfast presence to her work on the Board. We are among many who loved Janis and are grateful for her life.

Thank you for allowing me the privilege of serving in this role, and for everything that you and your congregations do to nurture and advance our saving faith throughout MidAmerica.

Report from Regional Lead

I write this report after coming to work for you, first in the Central MidWest District and then in our MidAmerica Region. This period of service has been deeply satisfying to me, and I feel deep gratitude to all of you. We have shared the challenge of discerning the small details of our life together—metaphorically how to arrange the furniture of our congregational lives—and the large questions of a deep economic recession followed by increasing calls for justice and reexamination of how we do things—both internal and external. This has been the movement for marriage equality. I can recall standing with many of you at the Illinois State capitol on a very rainy day in Springfield. And I can recall also standing with many of you in the rotunda of the Minnesota State capitol in St. Paul as *Standing on the Side of Love* banners were unfurled (or that would now be *Side with Love*). I remember equally marching with many of you in St. Louis on the first anniversary of Michael Brown's shooting. And that amazingly warm clear day two years ago in Cannonball, North Dakota, at one of the Dakota Access Pipeline witness.

I am struck by how much MidAmerica has been ground zero for the larger social movements of our time, whether this be Ferguson for Black Lives Matter, anti-Islamic and anti-Semitic hate crimes in many of our MidAmerica cities, the water crisis in Flint, in North Dakota for the new awakening of the indigenous movement for sovereignty and protection of the earth, or—in a very different way—the reaction which led to the election of Donald Trump.

I know that this has been a hard decade for the congregations and leaders of our region. I thank you for the devotion you have shown though all of this. This has been a hard decade for you—first restructuring financially in the face of the 2007 recession and then more recently with the grim social political situation in our country and the hard questions we have had to ask ourselves about our own structures, in the denomination and in our congregations, and how we can dismantle those structures that lead to white supremacist results in our institutions often contrary to our best intentions.

Beyond you, the congregational leaders, there are many others I wish to thank.

You, the district and regional team of program and administrative staff, have been amazing: Peggy Boccard, Kathy Charles, Nancy Combs-Morgan, Sharon Dittmar, Phil Lund, Gretchen Ohmann, Katie Phillips, Lisa Presley, and Andrew Zallar.

Through a time of unrelenting budget cuts and great institutional stress you have faced each new challenge with amazing spirit and with unfailing support of each other on the team and of me as team leader. You have done more than sustain the services to our congregations through these times. You have taken each new stress as an occasion to reinvent the work. I can remember this from the first year of the recession when Dori Davenport Thexton, Peggy Boccard, Gretchen Ohmann and our office assistant of the time—David Pyle—used the occasion of the fall in income from congregation in 2008 as a challenge to give up our brick and mortar office and create a virtual office. I think especially of Peg Boccard whose years of service and whose retirement we celebrate at

this Regional Assembly. This same spirit of reinvention in the face of challenge has continued down to the present when the MidAmerica team under the leadership of Nancy Combs-Morgan and Kathy Charles has begun to extend to the Southern Region a package of online faith development offerings. This same partnership with the Southern Region and support from our national office has also allowed us to create a new shared Congregational Life Consultant with youth portfolio and we have been joined by new colleague Cameron Young.

I wish to thank David Lauth, our current MidAmerica Board President, as well as all the other current regional board members, past regional board members, and members of our the three predecessor district boards: Heartland, Central MidWest, and Prairie Star. Your constant leadership, your support, and the reference point you have regarded concerning the needs and challenges of those we serve has been wonderful. We live in a time of questioning regarding how we do governance in our country as well as our association. It is not for us as staff to determine the evolution of these forms. But what we can say is that, given all the things you have helped us deal with month by month, and the larger perspective that you have given us at crucial points, I do not know how we could have accomplished without you what we have accomplished in this past decade.

I would like also to thank our nominating committees. We know from our congregations that nominating committees always have a very important and important task that tends to be invisible. The same is true for our region. And I fear to say one place that the structure of new region had crucial gaps and inconsistencies has regarded the functioning of our nominating committee. Some of these issues are only now being ironed out. In spite of struggling under this disadvantage, our nominating committee has served us well and in good spirit. For this I say thank you. For similarly invisible service I would also thank the MidWest UU Conference and MidWest UU Foundation who give our work crucial financial support.

One power trend in our work has been that our partners have become increasingly central to our work. I would like to lift up here our UU State Action Networks, as well as our UU religious professional groups, and also Black Lives UU, Diverse & Revolutionary UU Multicultural Ministries, TRUUST, and International Initiative for Transformative Collaboration (follow-up to the Standing Rock Witness).

I also thank our staff colleagues from our larger association. It may seem like an obvious thing that the staff of our larger association would support each other. What is not visible and what I want to recognize is that the congregations of MidAmerica have been especially challenged in maintaining their financial support of the region. In the face of this, other regions and our national association have stepped up quietly to give a variety of kinds of support to us as a regional staff and directly to you in congregations. Without this we absolutely would not have been able to maintain the level of services that we continue to provide. And, we thank all of you congregations who continue to be Honor level supporters of our work and all of you who are working to increase your support.

As I retire, which I will shortly after our Regional Assembly, I am excited about what lies ahead for our religious movement. I see us going through a fundamental rethinking of many of what my generation—the baby-boomers—have felt to be their greatest contributions in thinking regarding how to do church, beginning with a general question of the hierarchy, and focus on written policies and reports of policy governance. This will be exciting work. As to what I myself will be doing after retirement, I plan to work that out piece by piece. I can tell you that part of it will be spending a lot of time with our first grandchild, Helen, in California. That sounds especially inviting when in January and February the temperature hovers near zero in the upper Midwest. One passion project is going to be support of our five indigenous Water Protector Partners who have been made political prisoners after Standing Rock. I am determined that they will not be forgotten. Those who have already joined me in this effort I thank you. Any more who would like to become involved, let me know.

Again, and for everything, I thank you.

Midwest Unitarian Universalist Conference & Midwest Unitarian Universalist Foundation 2019 Annual Report to the MidAmerica Region & the Mountain Desert District

Midwest Unitarian Universalist Conference

History: With the consolidation of the American Unitarian Association (AUA) and the Universalist Church of America (UCA) in 1961, the Midwest Universalist Conference and the Western Unitarian Conference formed the Midwestern Unitarian Universalist Conference (Conference) and the Midwest Unitarian Universalist Foundation (Foundation). During the summer of 2018 the conference's name was legally amended to Midwest Unitarian Universalist Conference.

Purpose: The purpose of the Conference is to further the interests of Unitarian Universalists and their institutions in the mid-continental states (i.e., MidAmerica Region and the Mountain Desert District); to support those institutions to spread the message of Unitarian Universalism; and to distribute returns generated by funds held in trust by the Foundation, a subsidiary corporation. The purpose of the Foundation is to hold those funds received from the ADA, UCA, and other sources in trust, and to invest, administer, and safeguard those funds.

Funds: There are four funds for which the Conference and the Foundation are responsible:

- the General Fund, which provides an annual grant to the MidAmerica Region and the Mountain Desert District, and which can fund other initiatives. One of those initiatives is the fairly new Munroe Husbands Grant Program, which provides grants to lay-led (less than half-time ministerial support) congregations.
- the Ryder Fund (1888): the income is used to provide emergency financial support for retired ministers and their partners;
- the Iva Laughlin Fund (1903): the income is used to provide emergency financial support for elderly Unitarian Universalists; and
- the Colchester Fund (1926): the income is used to provide an annual scholarship that is awarded by Meadville Lombard Theological School in Chicago to a Unitarian Universalist theological student; and

Since June 2016, the MidAmerica Region has been the fiscal agent for the Midwest Unitarian Universalist Conference. This role is limited to holding funds distributed from the Midwest Unitarian Universalist Foundation related to the Ryder, Laughlin, and Colchester Funds, as well as limited funds to support small grants, such as those of the Munroe Husbands Grant Program, which provides grants to lay-led congregations for leadership development, communications tools for outreach and growth, and related matters.

The Conference Board has developed materials to publicize the funds available from the Ryder Fund and the Iva Laughlin Fund. The Board also sends money from the Ryder Fund to the UUA for distribution to retired ministers and their partners through the work of the Rev. Richard Nugent, Church Staff Finances Director consistent with the guidelines of the Ryder Fund. Both funds have been active distributing funds.

The Munroe Husbands Grant Program is new and began being advertised this fiscal year. The committee overseeing that program has recently received its first application.

Work improving the website for the Conference and Foundation (www.midwestuuconf.org) has continued this year. Board member Barb Gutsch has been serving as the Webmaster.

Committees: The Conference has several working committees: the Nominating Committee, Colchester Fund Committee, Laughlin Fund Committee, Ryder Fund Committee, and the Munroe Husbands Grant Program Committee.

A distribution in the amount of \$5,300 from the Colchester Fund was sent in spring 2018 to Meadville Lombard Theological School to be awarded by Meadville to a theological student(s) as the Colchester Scholarship(s) for the 2018-2019 academic year. Greta Seidohl was the Colchester scholarship recipient this year.

As the result of increased advertising both the Ryder Fund Committee and the Laughlin Fund Committee have continued to received multiple applications each year, and each has awarded multiple grants. During the fiscal year ending March 31, 2018, the Ryder Fund distributed grants totaling \$29,623.34, while the Laughlin Fund distributed grants totaling \$3,398.77.

Interim Meetings: The Conference directors and the Foundation directors work separately during the year via quarterly tele-conference calls and committee communications.

Annual Meeting: The Boards of the Midwest UU Conference and the Midwest UU Foundation hold their annual meeting in Chicago in early May, where they meet separately and jointly. The 2018 meeting was held on May 4-5, 2018. The 2019 meeting will be held May 3-4 in Chicago.

Distribution from the General Fund: Part of the agenda at the Annual Meeting was to determine the annual grants for 2018-2019 to the MidAmerica Region and the Mountain Desert District. These grants are based on a formula that takes into account the number of congregation members (weight 45%), the number of congregations (weight 45%), and the geographical size (weight 10%) of the region or district. The number of members and congregations was based upon UUA certification data as of February 1, 2018.

The maximum amount available for distribution is 4% of a rolling 13-quarter moving average of the Foundation's General Fund. The distribution for 2018-2019 is as follows: \$78,211 to the MidAmerica Region and \$21,310 to the Mountain Desert District, along with \$5,000 reserved for MUUC projects, specifically the Munroe Husband Grant Program.

Please note that the Midwest Unitarian Universalist Conference requires an annual report from both the MidAmerica Region and the Mountain Desert District to confirm that the work of these two organizations continue to be aligned with the purposes of the Conference which are listed above, and Conference's interests which are as follows:

- **Section 1a**. To facilitate the vitality and growth of Unitarian Universalism in the Midwest and Rocky Mountain states (i.e. Mid-America Region and the Mountain Desert District).
- **Section 1b**. To strengthen Unitarian Universalist congregations, districts, regions and organizations and institutions, including the Unitarian Universalist Association and Meadville-Lombard Theological School.
- **Section 1c**. To invite congregations to effectively serve the communities in which they are located in accord with their mission and the principles, purposes, and ends of the Unitarian Universalist Association.
- **Section 1d**. To encourage outreach and support of Unitarian Universalists living in the Midwest and Rocky Mountain states who do not live in communities served by Unitarian Universalist congregations.

Midwest Unitarian Universalist Foundation

The fiscal year is from April 1 to March 31. The total assets of the Foundation have grown from about \$200,000 in 1962 to \$3,286,032 as of March 31, 2018.

The financial statements are audited annually. The auditor of record for a number of years continues to be Wilkerson, Guthmann, and Johnson, Ltd. of Saint Paul, Minnesota. The audit report, dated October 16, 2018, for the fiscal year ending March 31, 2018 determined that the financial statements of the Midwest Unitarian Universalist Foundation presented fairly, in all material respects, its financial position, and the changes in its net assets and cash flows in accordance with accounting principles generally accepted in the United States of America.

The Foundation assets are invested in a variety of mutual funds and exchange traded funds which provide investment diversity. The Foundation determines its asset allocation each year and currently strives for a 70/30 allocation between equity and fixed income. The Foundation also is very sensitive to keeping investment expenses as low as possible while seeking reasonable returns.

MUUSJA (MN UU Social Justice Alliance). She presents several services at her church each year, generally on social justice or environment.

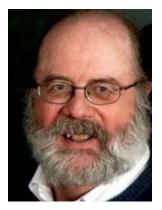
