10:10 AM PRESENTATION OF 2015 ANNUAL CLINICAL REVIEW HIGHMARK/ BOARD DISCUSSION

PRESENTATION & DISCUSSION	<p>The Highmark team presented a detailed two-year analysis of cost and utilization for the UUA Health Plan, comparing calendar year 2015 to calendar year 2014 results. This annual presentation provides an opportunity to discuss possible future plan enhancements.</p> <p>Pamela Cartwright, Lead Decision Support Analyst, presented a full review of member demographics, payments by demographic segment, changes in inpatient and outpatient utilization, urgent care and ER use, the incidence of high-cost members, and the performance of the targeted outreach program introduced in 2015. That program is showing early signs of success, with a high member-nurse engagement rate.</p> <p>Christopher Clark, DO, Medical Director, reviewed a broad range of clinical measures, analyzing both year over year results and comparison to Highmark national benchmarks. He highlighted the Plan's excellent performance in adherence to preventive screening guidelines. He also recommended that we move forward on a weight management program available through Highmark.</p> <p>Joe Cirrincione, Pharmacy Consultant, reviewed pertinent financial and utilization measures for our prescription drug benefit. He discussed the projected impact of current and emerging specialty drugs and the Highmark programs in place to manage utilization guidelines. His findings clearly supported the Plan's decision to enter 2016 with a 5-tier Rx plan.</p> <p>Barbara Johnson thanked our Highmark presenters, who signed out at 12:10.</p>

12:15	<p>DIRECTOR'S REPORT</p> <p>Jim reviewed the FY16 financials through Feb 29, 2016 (8 months) There were no notable actual-to-budget variances. Year over year, there were significant differences in claims paid and reinsurance recoveries. Ending net assets were virtually unchanged.</p> <p>Jim reviewed the calendar year operating results in the format used throughout the year to project rates for the next calendar year. For the first three months, the Plan is running a slight deficit, due to slightly higher than projected claims activity. The more important concern is a pending high-cost claim, incurred in 2015, but due to be paid in the 2nd Q. To facilitate a discussion about reserve levels, the CY2016 report shows a contingency reserve for the claim.</p>	JIM SARGENT

	Jim then provided detail on the timing and the prospective and retrospective review of the 2015 large claim, a heart transplant, to make the point that claims of this magnitude go through an extensive review process that assures strict adherence to clinical guidelines. This claim's impact on reserves will be on the agenda for the August and October meetings.
